1. Services Provided

2. Fees and Payment

2.1. Setup Fee: €500 (one-time, payable upfront)

2.2. Monthly Fee: €100/month

Includes all services in Section 1. Payment is due on the 1st day of each month.

2.3. Early Termination Clause:

- Cancellation before 12 months: €500 exit fee
- Cancellation after 12 months: €150 company closure fee

2.4. Non-payment Penalties:

- In case of non-payment, Growth Business LLC reserves the right to dissolve the company. Without other notice and shutdown the company's website.
- If payments are delayed or outstanding, Growth Business LLC is not obliged to submit annual tax filings or any other compliance reports.

3. Extra Services (upon request)

- Change from Single Member to Multi Member: €500
- Change of Operating Agreement: 1 free/year, then €100 per change
- Virtual Office: €50/month
- Apostille Package: €500 (Includes incorporation docs, Certificate of Good Standing, notarized Operating Agreement via online notary)

4. Term and Termination

4.1. The Agreement is valid for a minimum term of 12 months unless terminated earlier under Section 2.3.

4.2. Termination by either party requires 30 days' written notice.

5. Client Responsibilities

Provide accurate and complete documentation, including passports, legal names, and addresses of all members.

Ensure timely payment of monthly fees.

6. Limitation of Liability

Growth Business LLC is not liable for delays or issues resulting from incomplete or inaccurate client data.

Total liability is limited to the amount paid by the Client under this Agreement.

7. Governing Law

This Agreement is governed by the laws of the State of Wyoming, USA.

8. Entire Agreement

This Agreement constitutes the full understanding between the parties and supersedes all prior communications.

9. Amendments

No modifications shall be valid unless in writing and signed by both parties.

10. Severability

If any clause is deemed unenforceable, all other clauses shall remain in effect.

11. Counterparts

This Agreement may be executed electronically or in counterparts.
